


Crime Survey for England and Wales (CSEW)

- The CSEW has a long history of measuring the extent of crime in England and Wales
- Measures crime against adults ages 16+ living in private households
 - Additional interviews with children aged 10-15 within selected households
- Wide range of topic coverage including:
 - Incidence and prevalence of crime
 - Experience of domestic abuse
 - Fear of crime
 - Experience and perception of Anti-Social Behaviour
 - Crime prevention and security measures
 - Attitudes towards the police
 - Alcohol and drug misuse
 - Experience of domestic abuse, sexual assault, abuse during childhood.

Evolution

- The CSEW has been conducted via face-to-face interviews, using a continuous interviewing approach since 2001.
- However, the survey has evolved over that time.



Timeline of major changes to the survey




Evolution

- Interviewing was suspended in March 2020
 - CSEW was temporarily replaced with the TCSEW.
- Face-to-face interviewing resumed in October 2021.
- Increasing costs for f2f interviews and falling response rates mean f2f is less sustainable in the long-term.



CSEW response rate has dropped significantly since the pandemic




CSEW transformation


Objectives

- Improve sustainability of survey with reduced reliance on face-to-face interviews
- Increase precision and granularity of main estimates of crime by increasing sample size
- Modernise the survey with multi-modal approach

Approach

- Longitudinal panel design
 - Boost face-to-face interviews and re-interview previous respondents to the survey
 - This approach will build on the method used successfully over the pandemic to complete the Telephone-operated CSEW
- Initial interview (wave 1) completed face-to-face with a follow up interview (wave 2) completed after 12 months by telephone, or online. Wave 3 completed after a further 12 months





CSEW survey design (2022-23)

- Face-to-face sample design was adjusted to allow greater flexibility in target sample sizes
 - Moved to a simplified sample design
 - Minimum targets within Police Force Areas (PFA) were maintained
 - Total sample size (Wave 1 only) reduced to c. 30,000 interviews
- Introduction of new module on harassment added in April 2022 (article published Dec 23)
- An error in the survey script from Oct 2022 to Jan 2023 resulted in missing data for 10 key questions relating to partner abuse
 - As a result, estimates for the year ending March 2023 for domestic abuse, sexual assault and stalking were based on eight months of interviews and exclude the affected survey months. Additional weights (c11indivwgt_dv and c11hhdwgt_dv) were added to the 2022-23 data file for use in analysing this data.

CSEW survey design (2023-24)

- High-crime area boost sample was incorporated to increase the number of interviews achieved in high-crime areas
 - 6,000 of the 32,500 total interviews to be completed in high-crime areas
 - Defined as top 20% using the Crime Index from IMD
- Redesigned questions on domestic abuse added as a split sample experiment
 - These will be included on the survey until March 2025 (provisional date)
 - Expect to include findings from the trial in the next update scheduled for late 2024
- Experience of abuse in childhood module added to survey

Implementation of Wave 2+

- Currently all published estimates based on Wave 1 data
- Wave 2+ designed to be implemented with no impact on Wave 1 time series
- Separate analysis to understand the quality of Wave 2+ data and how to combine with Wave 1



Children's CSEW transformation

- CCSEW suspended between March 2020 and April 2022
- Precision and availability of data impacted by significant reduction in response rates post pandemic

Transformation objective:

 Develop an efficient, sustainable and resilient survey which delivers high quality, timely and inclusive data on children and young people's experience of crime-related topics and provides greater insights into experiences of vulnerable subpopulations

Approach:

- Programme of research (qualitative and quantitative) looking at the feasibility of moving data collection online
- Large scale online response rate test launching this month (issued sample of 7,000 children)
- Children sampled directly from administrative data sources (e.g., education, health data) as opposed to households who have responded to the CSEW
- Pilot results will inform a recommendation for the future of the children's CSEW, including recommendation to discontinue the face-to-face survey

Latest results (year ending September 2023)

Estimates from the Crime Survey for England and Wales for the year ending September 2023 showed that compared with the year ending September 2022:

- fraud decreased by 13%, with notable reductions in advance fee fraud (33%) and other fraud (40%)
- computer misuse increased by 30%, mainly because of a 36% rise in unauthorised access to personal information
- criminal damage decreased by 21%, including a 30% fall in criminal damage to a vehicle

There was no change in CSEW estimates of violence (which does not include sexual offences) compared with year ending September 2022 but estimates were 28% lower than year ending March 2020.
