Health Survey for England (HSE)



What is the Health Survey for England?

- Annual snapshot of the nation's health
- Health Examination Survey
- Tracks trends over time
- Cross-sectional
- Nationally representative sample
 - 8,000 adults and 2,000 children each year

HSE 2022

Report published in two parts:

- Part 1 Published in June 2024: Adults' health-related behaviours; Adults' drinking; Child health and health-related behaviours.
- Part 2 will be published later in 2024: Adult health; Overweight and obesity (adults and children); Social care provision; Kidney disease.

Data will be available on the archive later this year

HSE 2024

- Currently in field, face-to-face interviews only
- Fieldwork due to finish in February 2025 (interviewer) and March 2025 (biomedical fieldworker).

Core content includes:

- Interview: General health, longstanding illness, hypertension, diabetes, smoking, drinking, social care, height and weight measurements
- Biomedical visit: prescribed medicines, blood pressure, waist and hip measurement, blood, urine (not in 2024), saliva samples

HSE 2024

Additional content:

- Chronic pain (2017; 2024)
- Loneliness (2022; 2024)
- AUDIT alcohol questions (2022; 2024)
- Gambling (2021; 2024)

Adult Psychiatric Morbidity Survey (APMS)



What is APMS?

- Nationwide survey conducted roughly every 7 years since 1993
- Provides quality data on prevalence and trends in mental health in England
- Commissioned by NHS England and sponsored by the Department of Health and Social Care
- Run by the National Centre for Social Research in collaboration with the University of Leicester
- Called the National Study of Health and Wellbeing in field
- Target sample size: around 8000 interviews







Fieldwork

- Fieldwork for phase 1 of the core sample finished at the beginning of April and fieldwork for phase 2 finishes at the end of June.
- Two-stage design:
 - Phase 1 Survey questionnaire
 - Phase 2 Clinical follow-up assessment for a subsample of participants
- Two samples for 2023:
 - Core sample (including deprived area boost)
 - Representing Ethnic Minority groups sample –

Despite the best efforts, the performance of the Ethnic Minority group sample was below expectations. The projected volume of interviews achieved by the survey's closure would not have had a meaningful impact on APMS 2023 and to continue would not have been a good use of public funds. It was therefore decided to suspend the Ethnic Minority group sample pending a review on the methodology.



National Diet and Nutrition Survey (NDNS)



What is the National Diet and Nutrition Survey?

- Cross-sectional, continuous survey of diet and nutrition for individuals in the UK
- Designed to be representative of the general UK population

Provides the information needed to develop and monitor public health and protect food

safety





Adult Oral Health Survey (AOHS)



What is the Adult Oral Health Survey?

- Provides up to date surveillance information on adult oral health status, health inequalities, oral health related quality of life, and oral health behaviours
- Conducted roughly every 10 years since 1968
- The 2023 survey is covering England only
- Commissioned by the Department of Health and Social Care
- Consortium made up of:













AOHS 2023 Fieldwork

- AOHS 2023 survey is a paired visit for the first time (interviewers and dental examiners visiting households together)
- Up to two adults per household could take part
- Interview consists of two parts:
 - Interviewer: household questionnaire, individual questions on health and lifestyle, oral health behaviour, as well as scales including the Modified Dental Anxiety Scale and the Oral Impact of Dental Problems scale
 - Examiner: conducts a 20-minute examination of the mouth, gums and teeth. Looking at the health of intraoral soft tissues, presence of dentures, tooth condition, tooth wear, root condition
- Fieldwork took place from June 2023 to April 2024
- Analysis and reporting is now underway

The Gambling Survey of Great Britain



What is the Gambling Survey of Great Britain?

- Collects data on gambling behaviours among adults in Great Britain
- Includes Problem Gambling Severity Index (PGSI) and new questions on gambling harms and potentially negative consequences of gambling
- Push-to-web methodology, aiming for an annual sample of 20,000 adults
- Currently in its second year in field
